3. Course wise fee structure is available as “**Default Mode**” in the SBI Collect link. Last date of remittance of fee is **extended till 15 Aug 2022. No further extension will be granted.** The following mode of payment can be opted by Parents/Students for making payments through “SBI Collect”:-


