**DATE OF REPORTING**

2 You, along with your parents will report for admission in **Sep 2022** in formal attire with appropriate tie (Black pant, white full sleeve shirt & black tie for Boys and girls). Firm dates will be intimated in due course on receipt of commencement date from Bengaluru North University (BNU), Kolar, Bengaluru.

**DOCUMENTATION**

3 You must bring the following certificates, in original along with photostat copies duly attested (in 4 copies) and submit to this Institute at the time of admission:-

- (a) Proof of date of Birth.( Aadhaar, X, XI & XII Mark sheets)

- (c) Caste Certificate (OBC, SC and ST Category).
- (d) School/ Institute leaving certificate (Transfer Certificate).
- (e) Bonafide certificate & Character certificate from the School/ Institute last attended.
- (f) Migration certificate, in case you have passed qualifying examination other than from Karnataka State Board.
- (g) **06 copies** of coloured passport size photographs in shirt and tie.
- (h) After having passed in the (10+2) examination, if there is any gap between the period of college/ Institute last attended and joining AIHM & CT Bangalore, you have to submit an Affidavit, executed before a Magistrate on a stamp paper of requisite value (Rs 20/-), as applicable, stating that you have not joined any course of study during the said period in any other statutory University/ Institute.
- (j) Valid Dependent Card issued to Children of Army personnel.
- (k) ECHS Card in respect of Children of Retd Army Personnel.
- (l) Serving Certificate or Discharge book and PPO of parents.

### HOSTEL ACCOMMODATION AND MESSING FACILITY

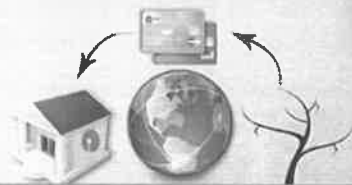
