EMD is to remain valid for a period of two months beyond the quotation validity period. EMD of the unsuccessful bidders will be returned to them at the earliest after expiry of the quotation validity and latest on or before the 30th day after the award of the contract. The EMD of the successful bidder would be returned, without any interest whatsoever, after completion of the work. EMD is not required to be submitted by those Bidders who are registered with the Central Purchase Organization (e.g. DGS&D), National Small Industries Corporation (NSIC) or any Department of MoD for MoD itself. In such cases, Valid proof of exemption of EMD should be attached with quotations failing which the quotations will be rejected by the Board. The EMD will be forfeited if the bidder withdraws or amends, impairs or derogates from the tender in any respect within the validity period of their tender.
