

ADMISSION PROCEDURE

Educational Qualification

3. Candidates who have passed their 10+2 examination conducted by CBSE, ICSE, Pre-University Examination, Karnataka Board or any other examination considered as equivalent are eligible for admission to BHM degree program, as per Bengaluru North University regulations.
4. Candidates who completed their 10+2 through distance education or privately through the National Institute of Open Schooling (NIOS) must have pursued the same combination of subjects in both 11th and 12th grades to qualify for admission.
5. Admission approval, fee refunds, and retention of original documents will be managed in accordance with the norms set by Bengaluru North University, and will be updated periodically as per university guidelines.

Selection Procedure

6 Admission is based on marks obtained in Class X and Class XII and online interview by Board of Officers.

7. Merit list will be prepared on the basis of marks obtained in Class X and XII in a ratio of 40:60 and online interview by Board of officers. In case of students appearing in class XII exams & results being awaited, the marks of class XI will be considered

8. Provisional admissions will be granted to students appearing for Class XII exam based on Class XI marks. However final admission will be based on meeting eligibility criteria. (Refer Para 7 above).

9. English is the medium of Instruction for the Programme at the institute.

10. Admission to the course shall be provisional. Final admission is subject to confirmation regarding eligibility criteria from Bengaluru North University.

Eligibility Criteria

11. Admission to this Institute is open to children of serving Army personnel, Ex-Army personnel, War widows. Limited seats for the **Indian Air Force, Indian Navy & other defence personnel**. Any vacant seats will be allotted to children of Assam Rifles, Paramilitary forces, Children of other civilians on availability of vacancy based on the merit list. **Seats** are allotted for **OP Sadbhavana** as recommended by Northern Command.

12. **Eligibility for Admission.** Eligibility conditions vide Article 235 of AWES Rule Book and HQ AWES letter No B//45840/A&R/AWES dt 09 Dec 2024 to be modified by including **additional categories** eligible for admission: -

12.1 **Priority I** : Children of serving retired Armed Forces (IA/IN/IAF) personnel as per auth distributions of seats be offered admission first. Once the candidates list is exhausted, the admission should be offered to priority II to IV applicants.

12.2 **Priority II** : Children of serving Paramilitary Forces personnel like Assam Rifles and Coast Guard etc. and children of retired Paramilitary Forces personnel granted regular pension, liberalized family pension, family pension, disability pension at the time of their superannuation, demise, discharge release medical board/invalided medical board and Spouses /Widows of serving armed forces personnel.

12.3 **Priority III**: Children of serving Central Armed Police Forces like CRPF, BSF, ITBP etc. if vacancies are existing after considering armed forces and paramilitary forces categories.

12.4 **Priority IV**: Civilians, not more than 10% sanctioned strength of the course if vacancies are existing after considering other eligible categories.

13. The children of the following categories of Armed forces personnel are eligible and required to submit the relevant certificates (as given against the category) as proof of their eligibility for admission to AWES Professional Colleges along with the application form.

13.1 **The applicants must fall into one of the following categories:-**

13.1.1. Children of serving Army personnel with a minimum of 5 years of continuous service in the Army (**Submit Certificate No 1**).

13.1.2. Children of ex-Armed forces personnel granted/awarded regular pension, liberalized family pension, family pension or disability pension at the time of their superannuation, demise, discharge, release medical board / invalid Medical Board. This includes wards of recruits medically boarded out and granted disability pensions. (**Submit Certificate No 1**).

13.1.3. Children of Ex-Armed Forces Personnel who have sought discharge or release after 10 years of service (**Submit Certificate No 1**).

13.2 **Adopted / Step Children and Children of Re-married Widows:**

13.2.1 Adopted child of Army personnel if adopted at least five years prior to seeking admission. (**Submit Certificate No 2**).

13.2.2 Step children are eligible provided they are born from a wedding where at least one parent belonged to the Army who is otherwise eligible (**Submit Certificate No 2**).

13.2.3 Air Force, Navy, Assam Rifles, Para Military Forces, CPO same as the Army Eligibility.

13.2.4. Civilians should be Citizens of India.

13.3. **Eligibility Criteria in Special Cases:**

13.3.1 **Eligibility Criteria for Wards of Ex Army Medical Corps Officers/Army Dental Corps Officers presently serving with Indian Navy or Indian Air Force (IN / IAF).** Wards of only those Ex Army Medical Officers/Army Dental Corps officers presently serving with the Indian Navy or Indian Air Force who have served with the Army for at least 5 Years(**Submit Certificate No. 3**).

13.3.2 **Eligibility Criteria for Children of Army Postal Service/ Military Nursing Service/ Territorial Army Personnel (Submit Certificate No 3).**

13.3.3. Wards of APS personnel classified as ex-servicemen as per Govt of India, Ministry of Defence letter No 9 (52)/88/D (Res) dated 19 Jul 89.

13.3.4 Children of those APS personnel who are on deputation and who have put in 10 years of service in the Army.

13.3.5. Children of APS personnel, who are directly recruited into APS who have completed 10 years of service and of those who as per their terms and conditions of service, retired from APS without reversion to the P&T Department after completing their minimum pensionable service of which 10 years was in the Army.

13.3.6. Children of only those members of MNS who have 10 years of service as regular members of MNS or are in receipt of pension from the Army.

13.3.7 Children of only those TA personnel who have completed 10 years of Embodied Service.

13.3.8. Wards of IN and IAF personnel, both serving and retired will be considered on availability of Vacant Seats.

13.3.9. Wards of serving personnel of Assam Rifles will be considered on availability of Vacant Seats..

15. A certified copy of the part II Order / Gazette notification conferring the award / copy of the award certificate should be attached with the application form for claiming the weightage. For Sena Medal (Gallantry) a certificate has to be obtained from MS – X that the Sena Medal awarded to the Officer is for acts of courage / bravery.

PHYSICAL AND MEDICAL FITNESS

16. The candidate should have good general health. The candidates must get themselves examined at the nearest Military Hospital or by a Registered Medical Practitioner and submit physical fitness certificate at the time of admission. The admission is subject to the candidate being medically fit.

ACCEPTANCE OF OFFER OF ADMISSION

17. **Selection.** On receipt of offer of admission, the candidate should acknowledge his/her acceptance to join the course **with Acceptance Fee of Rs 15,000/-** by a LINK within 10 days from the date of publication of result.

19. **Candidates are required to provide their e-mail id and mobile number for a prompt correspondence.**

COUNSELLING

20. The first 90 merit listed candidates will be offered admission. The decision of the Managing Committee in the selection of the candidates will be final.

SUBMISSION OF CERTIFICATES

21. The following certificates in original will be submitted at the time of admission: -

21.1 Marks card of 12th Std (10+2) examinations or equivalent examination.

21.2 Marks card of 11th Std (Mandatory).

21.3. Marks card of SSLC (Class 10) or equivalent examination.

21.4 School/Institute Leaving Certificate or Transfer Certificate.

21.5 Migration Certificate. Certificate from the Registrar of the University/ Board from which the candidate has passed the qualifying examination.

21.6 Proof of Gallantry award for grant of weightage vide Para-17 above.

21.7 **Character Certificate**. Certificate of good moral character from the Head of the Institution last attended.

21.8 **Willingness Certificate** in the prescribed format.

21.9 To address the measures to curb the menace of ragging in the college, it is mandatory to give an **UNDERTAKING** as per **Annexure I and II** on a Rupees Twenty Stamp Paper each. Admission to the college will be rejected in case the above undertakings are not submitted at the time of admission both from students and their parents. Students and parents to submit two undertakings each i.e., one for Hostel and one for Academics.

21.10 **Caste Certificate** (mandatory).

21.11 **Four copies** of latest **passport size photographs**.

22. All original certificates shall be submitted for verification at the time of the admission. Candidates are advised to keep attested copies of the certificates with them.

CONDUCT OF SEMESTER EXAMINATIONS

23 A candidate shall register for all the courses/papers of a semester for which he/she fulfills the requirements when he/she appears for examination of that semester for the first time.

23.1. There shall be Theory and Practical examinations at the end of each semester, ordinarily during November-December for odd semesters and during May-June for even semesters, as prescribed in the Scheme of Examinations.

23.2 Unless otherwise stated in the schemes of examination, practical examinations shall be conducted at the end of each semester. They shall be conducted by two examiners, one internal and one external and shall never be conducted by both Internal examiners. The statement of marks sheet and the answer books of practical examinations shall be sent to the Registrar (Evaluation) by the Chief Superintendent of the respective Colleges immediately after the practical examinations.

23.3 The candidate shall submit the journal book for practical examination duly certified by the course teacher and the H.O.D/staff in charge. It shall be evaluated at the end of the Semester at the practical examination.

CARRYOVER

24. Candidates who fail in lower semester examinations may go to the higher semesters and take the lower semester examinations. (A candidate who fails in a lower semester examination may go to the higher semester. However, no candidate shall be permitted to take the fifth-semester examination unless he/she passes all courses/papers of the first-semester examination and no candidate shall be permitted to take the sixth-semester examination unless he/she passes all courses/papers of the first and second semester examinations. Similarly, no

candidate shall be permitted to take the seventh-semester examination unless he/she passes all papers of the first three semester examinations and no candidate shall be permitted to take the 8th-semester examination unless he/she passes all papers of the first four semesters' examinations). Programme structure for bachelor of hotel management will be published periodically.



Jurisdiction of Court Cases.

32. All court cases and legal matters, if any will be dealt within the jurisdiction of Bengaluru Only.

JURISDICTION OF COURT IN CASE OF DISPUTE

33. All disputes related to admission to the Institute and any other matter pertaining to Army Institute of Hotel Management and Catering Technology (AIHM&CT) shall fall within the jurisdiction of Courts in Bangalore only.

DISCIPLINE

34. AIHM&CT lays stress on conduct and discipline as under: -

34.1. Each student will be issued an identity card having his/her photograph affixed to it. The identity card must be always carried by the student and presented for inspection when demanded by an authorized person.

34.2. Students are required to be punctual and regular in attending classes and to appear for all tests and examinations. If the attendance falls below 75%, or if his/her academic performance is not upto the required standard, he/she may be debarred from attending the semester examination as per university guidelines. Students shall obtain their classroom attendance details from their class teacher/ mentor every fortnight.

34.3. If any of the statement made in the Registration Form or any information provided by the candidate, in connection with his/her admission is found to be false or incorrect at any later date, his/her admission will be cancelled. Fees will be forfeited and he/she may be expelled from the Institute.

34.4 **Implementation of Nasha Mukh Bharat Abhiyaan (NMBA).** Drug and Substance abuse is a ongoing issue. USC guidelines will be adhered to and AIHM&CT is part of NMBA. Anti-drug Declaration form has to be signed by student.

CHANGE OF ADDRESS

35. Change of address if any, as given in para 13(a) of the application form should be intimated immediately along with correct telephone no. and mobile number of the parents, to avoid loss of communication.

LOCAL GUARDIAN

36. The parents of the students should nominate a local guardian residing in Bangalore or nearby for immediate communication concerning the student. Local Guardian reference is mandatory.

RAGGING

37. 37.1. Ragging is banned in educational Institutions and hostels and any one indulging in such acts shall be subject to punishment by a Court of Law/concerned authorities.

37.2 In case of ragging, please dial 1800-180-5522 or 155222, toll free anti-ragging help line 24 x 7. Extract from the circular No ED 99 URC 99 dated 16 Aug 1999 issued by the Education Department, Govt of Karnataka, reproduced in Karnataka Education Act, 1983 (Karnataka Act No. 1 of 1995) Section 2 (29) "Ragging" means causing inducing, compelling or forcing a student, whether by way of a practical joke or otherwise, to do any act which detracts from human dignity or practical joke or otherwise, to do any act which detracts from human dignity or violated his persons or exposes him to ridicule or to forbear from doing any lawful act, by intimidating wrongfully restraining, wrongfully confining or injuring him or by using criminal force to him or by holding out to him any treat of such intimidation, wrongful restraint, wrongful confinement, injury or the use of criminal force.

37.3 Instructions of HQ AWES vide letter No B/45807/WC/AWES/CW-09 dated 26 Apr 2000 are as under:-

37.3.1 Instances of ragging of students is an unbecoming conduct and inhuman nature. Such cases, besides damaging a student's psyche, adversely affects the reputation of the institution.

37.3.2. With immediate effect all forms of ragging will be strictly forbidden in AWES run institutions.

37.3.3. Management will ensure strict compliance and take strict disciplinary action against defaulters.

37.3.4. This has the approval of the Chairman Executive Committee AWES.

37.4 Ragging is not allowed in the college. Students accused of ragging and found guilty after due investigations, would be expelled from the college.

37.5. The candidate and the parent must submit an undertaking for the prevention of Ragging as per UGC guidelines.

37.6. The student as well as parents are required to give undertaking as per Honorable Supreme Court guidelines.

FEE STRUCTURE

REFUND OF FEES AND ALLIED CHARGES

39. In case of withdrawal from the admission process by the candidate or withdrawal from the Course, the refund of fees will be made as per AWES rules and norms in vogue. (Authority- AWES letter No. B/45903/SC/AWES dated 19 Dec 2008)

39.1. Candidate will be required to deposit Rs 15,000/- by due date as mentioned in the Admission scheduled for 2026. This amount will be adjusted against the first installment of the fee when the candidate is admitted.

39.2 After registering the willingness to join, if a candidate fails to report or withdraws from the course, refund of fee will be as per details given below (written application for withdrawal should be given and the date of receipt of application will be considered for refund of money).

39.2.1 Refund of Registration Fee Before Commencement of the Course/Cut off Date. If a candidate does not join the course before the cut off date, full Registration fee less Rs 3,000/- processing charges will be refunded after the closing of admission.

39.2.2 Refund of Fees after joining the Course incase of withdrawal of admission.

Rules and Discipline for Admission in Hostel

1. Admission is open to full time students of AIHM&CT.
2. The application form completed in all respects should be submitted to the Admin Office on any working day during office hours.
3. Admission to the Hostel will be cancelled if incomplete or false information is furnished.
4. Hostel Accommodation will be allotted based on academic performance.
5. Hostel rules are available for perusal on website.
6. Students will be required to vacate the room within 3 days on completion of the scheduled examination each semester.
7. Students are not allowed to stay in the Hostel during the Winter / Summer vacations during internship
8. The hostel fee for the next acadernic year is required to be paid in the month of May/June.
9. AIHM&CT reserves its right to cancel admission of undeserving students without giving any reason.
10. AIHM&CT reserves its right to increase the hostel fee, if necessary.
11. AIHM&CT will not be responsible for any mishap.
12. Student residing in the Hostel managed by AIFD shall strictly observe all the Rules and Regulations in force from time to time. Breach of rules / regulations may invite rustication/ fine.
13. During their stay in the Hostel they will be under the control of the Officials of AIHM&CT
14. Smoking, consumption of alcoholic drinks and drugs is strictly prohibited in the hostel premises.
15. No guest or visitor of the inmate will be permitted to visit rooms. Visitors and guests should be received in the Visitors room or Reception area only between 9.00 am. to 6.00 p.m.
16. Every student shall be in his/her hostel by 9.00 p.m. If he / she has to stay out after the said timing owing to any special reason, he / she must obtain prior permission from the Registrar.
17. The application for leave of absence from the hostel shall be made in writing through Mentor/Hostel In-charge/HOD/ to the Principal and Registrar and his/her permission shall be obtained. Late entry without prior permission will invite penalty/rustication.
18. No students shall use the service of a hostel servant for personal work even on payment. He/she shall also not bring any servant from outside even temporarily.
19. Students will not enter rooms of other students without permission of the inmates. Students should not go to other students flat after 10.00 p.m. in the night.

20. Every case of illness and accident must be reported immediately to the Warden and Registrar.
21. No functions or celebrations shall be organized except with the permission of the Registrar.
22. Resident students are not permitted to convene any meeting of any sort under any circumstances anywhere in the Hostel premises without the prior permission of the Registrar or the Management.
23. No poster etc. should be put up anywhere, either in rooms or lobbies.
24. Students are not allowed to play any kind of sports in the room
25. Throwing of water, colour etc. on one another and on the walls / property of the hostel is strictly prohibited.
26. Students suffering from any contagious disease will not be allowed to stay in the hostel. The decision of the Registrar in this regard will be final and binding.
27. Allotment of the room, furniture etc. will be entirely at the discretion of the Registrar / Warden and no complaint in this regard will be entertained.
28. Every student shall keep the room allotted to him clean and neat. He/She shall take proper care of the furniture and fixtures handed over to him/her. The hostel authorities have the right to enter and inspect the rooms at any time, even in the absence of students.
29. All matters relating to differences among students and complaints about the hostel servants shall be brought to the notice of the Registrar, who will take such action as may be necessary. No police complaint will be lodged by the students before taking prior permission from the Registrar.
30. Students are expected to switch off the lights and fans in their rooms every time they go out and take precautions to economies electricity consumption.
31. Charges for any damages to the property as well as to the furniture and fixtures caused by a student/students negligence will be recovered from the student/students staying in the said room.
